#### 10am- call to order

- 1- The agenda was adopted by consensus.
- 2- A motion was made, seconded and approved to accept the June minutes.
- 3- The treasurer's report was briefly discussed and approved.
- 4- Refuge report
  - a. Visitation is down probably due to the heat. There was vandalism at several locations and the Shired Is. restroom is closed.
  - b. Burning will start again in the next few days.
  - c. The restoration area south of headquarters will be planted with longleaf pine and wiregrass.
  - d. The Seahorse Key platform is not being used by target species. Other nesting areas are not productive due to human and pet disturbance.

  - a. Visitor Contact
    - i. The program is still shut down.
  - b. Interpretive media
    - Larry reported that he asked the Chiefland Print Shop print Daniel Barrand's Refuge maps and paid for them. Friends cannot reimburse the Refuge so no funds will go towards them.
    - ii. Larry explained the Avenza maps app. Peg and Debbie will post Daniel's maps on the website for download.
    - iii. Debbie reported that John M. inventoried the brochures and the Top 10 is surprisingly low- as if a box is missing. Larry will look in the shed.
  - c. Online Communications
    - Peg reported that the News Brief went out yesterday with 211 of 350 opening it. The click rate remains very high. The Jaguarundi and Larry's two stories were the top clicks.
  - d. Inventory and Sales
    - i. No sales. There is no word yet about whether the Seafood Festival will be held which will be a reason to restock.
  - e. Kite Project
